Accepts the Terms and Conditions

1. When registering or purchasing (in both cases), the user is obligated to accept the terms of this Terms and Conditions by selecting the check box on the form. Upon acceptance of the terms and conditions of the TC, the present contractual agreement between the Service Provider and the Web Store user shall be established.
2. If the user does not accept the terms of the TC, he or she may not use the services of the Web Store. You can not place an order.

Steps for ordering:

1. Select product, 1 TRAY / 2 TRAY / 3 TRAY (1 TRAY = 24 CAN)
2. Composing the order
4. Fill in your personal information
5. Acceptance of the TC
6. Payment of order (via online banking transaction, forward)
7. Confirmation of Order

The conclusion of the sale contract:

1. If the user sends an order to the Web Store pages and the service provider confirms the order by e-mail, a sales contract will be created between the buyer (user) and the service provider. (If no email arrives to the buyer within 48 hours, the buyer will be exempt from the bidding obligation, and will not be obliged to buy the ordered product, to use the service.)
2. The user accepts that the contract thus concluded is considered to be in writing and is governed by the law of Hungary. The contract is governed by the provisions of this GTC.
3. The contract is created in English, and the Web Store is automatically stored in electronic form.
4. Our company reserves the right that we can serve your orders in the place of arrival, we keep in a record the sum of the order as deposit arrived to our company. The package contains the invoice in every case.

Essential properties of the product

The essential features of this product can be viewed by users on product demo pages.

Prices

The prices published in the Webshop are gross prices, including the price of the products and the shipping costs.

Delivery

1. Delivery deadlines can be found on the demo pages of the product.
2. The delivery of the products is done by the service provider at a time agreed with the buyer.
3. The buyer must check the integrity of the package at the time of dispatch. In case of damaged packaging, the error must be recorded on the spot in the minutes.

Possible ways of payment

Warranty Information, Product Warranty and Warranty Information

We undertake a warranty period in accordance with current legislation. All other warranty periods or warranties, as well as the warranty period, are excluded from the goods in question. Seller's warranty and warranty obligation under the Civil Code. government regulation.

How to report a warranty or warranty claim

1. Personal filing

The buyer can personally report a warranty or warranty claim to the Service Provider

(Hungary H-1025 Budapest, Törökvész u. 123 / B.).

At that time the Service Provider's staff takes note of the objection, stating:

- the buyer's name, address,
- the name, purchase price of the product,
- the date of purchase,
- the date of notification of the fault, - the description of the fault,
- the claim to be enforced by the buyer,
- how to handle the objection.

If the manner in which the objection is addressed deviates from the buyer's need, the reasons for this are set out in the minutes.

A copy of the minutes is handed over by the buyer.

2. Written notification

The customer can declare his warranty or warranty claim by email to the Service Provider or by e-mail (**kosher@kosherenergydrink.com**).

The letter must then include: - name, address,

- name, purchase price of the product,
- date of purchase,
- date of notification of the failure,
- the description of the error,
- the claim that the buyer wishes to enforce.

Data handling

The operator treats the personal information provided to him in the use of his web site as confidential and does not disclose it to third parties except in the case of his subcontractor. (Eg courier service), it is necessary to deliver the order.

During the web shop browsing, technical information is recorded for statistical purposes. (IP address, duration of visit, etc.). These data shall only be legally credible to the operator and, if supported, communicated to the authorities. You must enable cookies to access the service. If you do not want to enable cookies, you can disable it in your browser settings. When blocking cookies, some features of the service are only partially or totally unavailable. A cookie is a file that the server sends to the user's browser and is stored by the user's computer. Personal data will not be stored in the cookie. The data recorded during the order will be used by the operator to complete the order. The invoice data generated by individual IT systems on the web site's pages is recorded with the data provided

during the delivery of the order and stored for the period specified in the current Accounting Act. When browsing the webshop or signing up for a newsletter subscription, the information is kept confidential by the operator, and unsubscription may be requested in one of the specified contact details. You can always delete or modify your data in writing.
